

**Project Hail Mary- Sweepstakes
OFFICIAL RULES**

1. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE THE ODDS OF WINNING.

2. GENERAL INFORMATION. Project Hail Mary Tech Bundle Sweepstakes sponsored by NCG Cinemas begins at 12:01 a.m. Eastern Time on March 1st and ends at 11:59 p.m. Eastern Time on April 1st.

3.
